

Early Childhood

 97% client satisfaction from parents of children at <u>Thompson Child</u> <u>Development Center</u>. Approximately 97% of children met or exceeded their developmental expectations, as measured by the Teaching Strategies GOLD assessment.

Foster Care

In the Loop

- 94% Foster Parent Satisfaction FYTD.
- 90% Youth Foster Home Satisfaction FYTD.
- 90% Placement Stability (FYTD 90%) where children had 2 or fewer placements while enrolled.
- 92% of children were not discharged to a higher level of care, including psychiatric hospitalizations (FYTD).
- 43% of children achieved permanency through reunification or adoption/guardianship (FYTD).

Mental Health

 Family Centered Therapy families expressed a 94% Client Satisfaction, and 100% experienced Mental Health Gains FYTD.
 86% of families also maintained placement with family of origin. My child seems happier, calmer, and more peaceful. I am beginning to see a lot of little changes. Parent of School-Based Therapy client

- 100% of Intensive In-Home families report in May that they had improved at handling daily life and related challenges (91% FYTD). Families expressed a 100% Client Satisfaction rating in May (95% FYTD).
- Both Outpatient and School-Based Therapy clients gave 100% Client Satisfaction ratings in May (FYTD results are 96% and 100% respectively).



- Wrap clients reported 99% Client Satisfaction in May (98% FYTD).
- 100% of Short-Term Residential (Crisis Stabilization Program) youth were discharged to a long-term placement within 65 days of enrollment in May. Youth CAFAS scores from enrollment to discharge saw an 18 point reduction.
- PRTF saw 88% Parent and Youth Satisfaction ratings, and 84% of youth reported that they feel better able to manage their emotions than when they first arrived at Thompson (FYTD).
